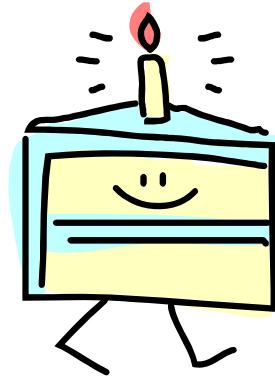
For a fun filled time at the Sheraton Hotel and Conference Center,
